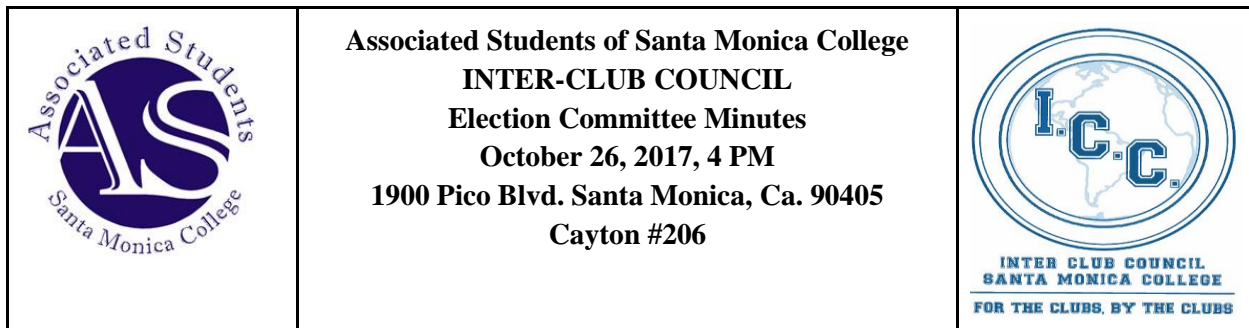

If someone expresses financial need they can get up to 100 dollars reimbursed. Have time after the election to submit 100 per candidate. Very financial need. They may spend 250 and only reimburse 100 only if they have financial need. Must turn in all receipts spent. In-kind donation. March 16<sup>th</sup> 5pm – Knowing the director who will be running. Submit proposal of the amount of money that will be spent for campaigning. Club endorsement- Candidate having issues to announce or campaigning club.
