Upon review and approval, a Vehicle Parking Permit will be issued to the applicant(s) for the specific academic semester requested only.

In order for a vehicle to park in a Car/Van Pool designated space, the vehicle **MUST** display a valid Car/Van Pool parking permit and a valid, parking permit or valid daily parking permit, as well as having a minimum of (3) occupants in the vehicle when it is parked. Car/ Van Pool parking permits are valid only for the driver(s) and vehicle(s) listed on the application.

If a person displays a valid Car/Van Pool parking permit issued to another person or vehicle, that vehicle is subject to a citation. The Car/Van Pool parking permit will be seized and a report will be forwarded to the Vice President, Student Affairs. The seized Car/Van Pool parking permit will not be returned to the person(s) who applied for the permit.

CITATIONS WILL NOT BE RECOMMENDED FOR DISMISSAL FOR A LOST, FORGOTTEN, IMPROPERLY DISPLAYED CARPOOL PERMIT, OR NOT KNOWING THE DISTRICT PARKING REGULATIONS. PERMIT MUST BE PLACED ON DASHBOARD AND READABLE FROM OUTSIDE OF THE VEHICLE AT ALL TIMES.
