

Volunteer To Assist At VITA Event

Founded in 2017, Volunteer Income Tax Assistance (VITA) at SMC provides free federal and state income tax preparation assistance to eligible low-to moderate-income individuals living in the state of California. This event typically occurs from February 9 through April 7.

- <u>Requirements:</u> Pass IRS examination and show certificate for each of the following categories: tax preparer (basic and advance), quality reviewer, and supervisor
- <u>Preferred qualifications:</u> successful completion of ACCT 17 Individual Income Tax Preparation course at SMC
- Application Deadline: Typically November 30
- Application Process: Email <u>rubio_cesar@smc.edu</u> for the most current information. Applicants will be required to submit proof of IRS examination certifications, a resume, and a cover letter

CPA Licensure

Assuming you wish to be licensed in California, you will need to have met the following educational requirements to obtain a California CPA license:

- Bachelor's Degree or higher
- A total of 150 semester units including:
- 24 semester units of accounting subjects
- 24 semester units of business-related subjects
- 20 semester units of accounting study
- 10 semester units of ethics study
