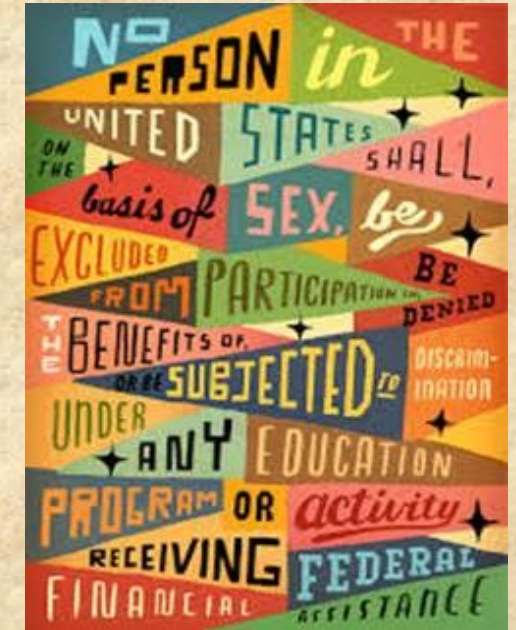

## WHAT'S SEX GOT TO DO WITH IT?

"No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance."

- Title IX of the Educational Amendments of 1972 to the Civil Rights Act of 1964

Sexual harassment under Title IX includes:

- Quid pro quo: When an employee conditions the provision of an aid, benefit, or service of the College on an individual's participation in unwelcome sexual conduct;
- Hostile environment: Unwelcome conduct determined by a reasonable person to be so severe, pervasive, and objectively offensive that it effectively denies a person equal access to the District's program or activity;
- Sexual assault, dating violence, domestic violence, or stalking.

SMC is committed to building a safe, inclusive and diverse community. The College prohibits unlawful discrimination and sexual harassment in any of its programs and activities.



## KNOW YOUR RIGHTS

You have the right to:

- Feel safe; Be safe
- Say, "No" and not feel pressured to engage in sexual activity
- A relationship with someone who respects your emotional and physical wishes and boundaries
- Be assertive and direct with someone who is sexually pressuring you
- Change your mind, and if you are not sure what you want, STOP and think about it
- Be in a relationship free of violence and abuse
- Make a confidential police report, by requesting that you remain anonymous for the public criminal record

## WHAT IS CONSENT?

Consensual sexual activity happens when each partner willingly chooses to participate. Openly communicating about expectations and desires is critical to obtaining consent. Consent must be voluntary and freely given. Silence, lack of protest or resistance does not mean consent. Even if someone has agreed to engage sexually, that person has the right to withdraw their consent at any time.

## SEX WITHOUT CONSENT

Sex without consent is sexual assault. Sex resulting from the use of force, threat, intimidation, exploitation, or coercion constitutes sex without consent and is assault.

Consent cannot be given if you are:

- under 18 years of age;
- incapacitated by drugs or alcohol;
- unconscious; and/or
- unable to understand the fact, nature or extent of the sexual situation.

## SEXUAL ASSAULT

If you are sexually assaulted, contact the Human Resources' Compliance Administrator/ Title IX Coordinator or Campus Police (see reverse side of this brochure for contact information).

Sexual assault allegations affect all involved. Resources offered to all parties may include medical, psychological, and other support.

An investigation may be conducted and appropriate action taken.
